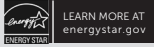

LOCATING YOUR UPC

All product packaging includes a Universal Product Code (UPC). A UPC or product code includes up to 12 numbers which are a unique identifier for the product. All digits must be included with items you are submitting for a rebate. We encourage UPCs be cut out and mailed along with the rebate application and sales receipt - this will assist in ensuring a timely review and processing timeline.

Helpful tip: Many lighting products show the product's Model/Item Number directly above the UPC barcode.
